

# Diversified Woodcrafts, Inc's "Create & Explore 40K Giveaway"

## Rules and Guidelines

1. All entries must be a digital video.
2. The length of the video should not exceed 2 minutes (120 seconds), not including the 10 second title screen (see #3).
3. All entries should begin with a 10 second full-screen "title screen" that includes the following information:
  - Producer's Name
  - School Name
  - School City, State
  - Title of Video
  - Total running time (not including the 10 second title screen)
4. All information presented in the video must be cited, giving credit to the original source. Plagiarism of any kind will result in disqualification. IF CHOSEN AS A FINALIST, you must submit a list of your sources, properly cited.
5. Each video must have one Lead Producer. While several people may work together on the project, it must be submitted under only one name. The final prize will be awarded to the school.
6. There is no entry fee.
7. Entries may be submitted at: <http://bit.ly/1FyeNqi> starting on October 30, 2014. The deadline for submissions is 5:00 pm (CST, US) on January 31, 2015. Voting ends February 28, 2015. Winners will be announced no later than Thursday, April 1, 2015.
8. All entries must be submitted in digital format.
9. No copyrighted materials (music, images, etc.) may be used for this contest unless you own the copyright or have a license to use the material for this contest. Written permission must be obtained and provided upon request for all copyrighted materials.
10. No professional assistance is allowed.
11. All portions of the on-line entry form must be completed when you upload your video for it to be eligible.
12. IF CHOSEN AS A FINALIST you must submit a signed/completed Parent Permission Form if 17 years old or younger and a signed/completed Actor Release Form for each person appearing in your video.
14. Content must comply with all local and national laws of the country of origin and the United States. Content must not 1) promote illegal behavior; 2) support racial, religious, sexual or other invidious prejudice; 3) advocate sexual or violent exploitation; 4) violate rights established by law or agreement; 5) invade the privacy of any person; or 6) be otherwise inappropriate as determined by Diversified Woodcrafts in its sole and conclusive determination.
15. Employees of the Diversified Woodcrafts and their immediate families or those living in the same household as an DWI employee are not eligible to enter this competition.
16. Each individual contest participant is restricted to one video submission only, whether an individual or a team submission.
17. The top ten highest rated submissions will be judged by a panel appointed by Diversified Woodcrafts. Members of the judging panel will consider the following criteria in making their selections:
  - Why your school needs new furniture
  - What piece of our furniture would be your dream piece
  - How would you use the furniture
  - Overall creativity of video
18. The decisions of the judges are final and incontestable. Winners will be notified by April 1, 2015
19. The only compensation for submitting a video is the opportunity to be awarded a prize if the entry wins. Diversified Woodcrafts will pay filmmakers no additional compensation nor be liable to the filmmaker under any circumstances.
20. Students should keep at least one copy of their video. Diversified Woodcrafts is not responsible for any films that are lost, damaged, or that do not upload properly.
21. Ownership of the underlying intellectual property of the project remains with the entrant, with the following exceptions: Entrants grant Diversified Woodcrafts the right to use their names, photographs, statements, quotes, testimonials, and video submissions for advertising, publicity, and promotional purposes without notification or further compensation.
22. Entrants also grant Diversified Woodcrafts the right to use, reproduce, reprint, distribute, perform, and/or display the entrant's project video without further compensation or notification to the entrant.
23. Diversified Woodcrafts maintains the right to reproduce, reprint, distribute, perform, display, or exhibit the project for advertising, publicity, and promotional purposes on their website, at conferences, or at any other venues.
24. By accepting the prizes, winners agree to hold Diversified Woodcrafts and all Diversified Woodcrafts employees harmless against any and all claims and liability arising out of use of such prizes. Winner assumes all liability for any injury or damage caused from participation in the contest or use/redemption of any prize.
25. Entrants agree to be bound by the official contest rules and decisions of the judges.
