TWISTED TEA® A LITTLE TWISTED CHOPPER VIDEO SWEEPSTAKES

ELIGIBILITY: Twisted Tea® A LITTLE TWISTED CHOPPER (the “Sweepstakes”) is open to legal residents of the United States in any legal U.S. state who are at least twenty-one (21) years of age at the time of entry. The random drawing, selection of a winner, and awarding of the prize will be conducted under the supervision of Administrator, an independent organization whose decisions are final and binding in all matters pertaining to this Sweepstakes.
