AURORA IMPORTING 60th ANNIVERSARY CONTEST RULES

A name, valid e-mail address and phone number will be required. Validly submitting a completed entry form through the Contest Website or at an in-store location will grant the entrant one (1) entry for participation in the draw (described in Section 5 below) corresponding to the Contest Period during which the entry was made.
