- **3. Contest Period.** The Contest begins on August 19, 2016 at 09:00 A.M. Scottsdale, Arizona time and continues until September 16, 2016 at 12:00 P.M. Scottsdale, Arizona time ("Contest Period"). Sponsor's computer is the official timekeeper for the Contest.
