

**ETHAN ALLEN \$50,000 DREAM ROOM SWEEPSTAKES 2016
OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR
CHANCES OF WINNING.**

ELIGIBILITY: OPEN ONLY TO LEGAL RESIDENTS OF THE FOLLOWING TERRITORIES (“TERRITORIES”): THE UNITED STATES AND CANADA (EXCLUDING ALASKA, HAWAII, PUERTO RICO AND OTHER U.S.TERRITORIES AND POSSESSIONS AND EXCLUDING QUEBEC, THE YUKON AND NORTHWEST TERRITORIES, AND MANITOBA IN CANADA (COLLECTIVELY, THE “EXCLUDED TERRITORIES”). Mail-in entries must be received by September 27, 2016. Limit one (1) entry online or via mail and five (5) entries from the Design Center per person/address/household for the duration of the Entry Period. Entries in excess of the stated limitation will be void. Entries generated by script, macro or other automated or mechanical means or by any means which subvert the entry process are void. All entries become the property of Sponsors and will not be acknowledged or returned.
