1 – SWEEPSTAKES DATES: The *Energizer* Holiday Sweepstakes (the "Sweepstakes"), sponsored by Energizer Battery, Inc. begins at 12:00:00 AM Central Time ("CT") on November 29, 2013 and ends at 11:00:00 PM CT on December 22, 2013 ("Entry Period") which is further divided into twenty-four (24) Daily periods (each a "Daily Period") as defined in the chart below. For purposes of this Sweepstakes, a "day" is defined as a 24-hour period, beginning at 12:00:00 AM CT and ending at 11:59:59 PM CT (except for the last day of the promotion in which entries must be received by 11:00:00 PM CT). The Sponsor's computer, or that of its designee, runs the official clock for the Sweepstakes and will solely determine the time by which an entry is received.
