

**RENT.COM MARCH PADNESS SWEEPSTAKES**  
**OFFICIAL RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

**DATES OF SWEEPSTAKES:** The “March Padness” Sweepstakes (the “Sweepstakes”) begins at 12:00 PM Eastern (“ET”) on March 16, 2014 and ends at 6:00:00 PM ET on March 30, 2014 (the “Sweepstakes Period”), subject to entry periods (each, an “Entry Period”) as outlined in the How To Enter section of these Official Rules. Prize Winners will be selected from entries properly submitted to the Sweepstakes.

**ELIGIBILITY:** In order to be eligible for entry into the Sweepstakes, you must be: i) a legal permanent United States resident residing in the 50 United States or the District of Columbia, ii) 18 years of age or older prior to the start date of the Sweepstakes (each, an “Entrant”). All employees of RentPath, Inc. Each subsequent Entry Period 6:01 PM ET and ends at 6:00:00 PM ET the following day, according to the dates listed in the Chart above in the "How To Enter" section, and all entries must be submitted during this time in order to be included for that Entry Period drawing and subsequent Entry Period drawings.

On the Entry Period drawing date listed in the Chart, two potential Entry Period prize winners (each, a "Prize Winner") will be selected from among all eligible entries received in that Entry Period and/or previous Entry Periods by the Sponsor, whose decisions are based on its sole discretion and interpretation of these Official Rules, and are final and binding in all respects. Two (2) Entry Period Prizes of a \$100 VISA gift card will be awarded per Entry Period for Entry Periods 13–14. A total of twenty-eight (28) Entry Period Prizes will be awarded having an approximate retail value ("ARV") of \$25 - \$100 each.
