

RENT.COM "SHOW YOUR CITY" SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

DATES OF SWEEPSTAKES: The "Show Your City" Sweepstakes (the "Sweepstakes") begins at 10:00 AM Pacific ("PT") on April 28, 2014 and ends at 2:59:59 PM PT on May 23, 2014 (the "Sweepstakes Period"), subject to entry periods (each, an "Entry Period") as outlined in the "How To Enter" Section of these Official Rules.

ELIGIBILITY: In order to be eligible for entry into the Sweepstakes, you must be: i) a legal permanent United States resident residing in the 50 United States or the District of Columbia, and ii) 18 years of age or older prior to the start date of the Sweepstake (the "Entrant"). Employees and their immediate family members (parents, children, siblings or spouse, regardless of where they live, or persons living in same household, whether related or not) of RentPath, Inc. Complete and submit the Official Online Registration Form, in its entirety, including first and last name, email address, city, state, photo caption, and upload an original photo taken by the Entrant of a city in one of the fifty (50) United States or District of Columbia. Then click "submit" to complete your entry. You will need to complete the process above only once to be eligible to win the Sweepstakes. Entrants may enter more than once provided that different photos are submitted for each entry (i.e., entries with duplicate or near duplicate photos will not be considered valid entries). In order for an entry to be valid, Entrant must provide a valid e-mail address and must complete all required information on the Official Online Registration Form. Entries having incomplete information will be disqualified and ineligible to win.

ENTRY PERIODS: The first Entry Period will run from 10:00:00 AM PT and ends at 2:59:59 PM PT. Each subsequent Entry Period will run from 3:00:00 PM PT and end at 2:59:59 PM PT, according to the dates listed in the below chart.
