



**CHOOSE MY NAME SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

OPEN ONLY TO LEGAL RESIDENTS OF FLORIDA WHO ARE AT LEAST 18 YEARS OLD AT THE TIME OF ENTRY.

VOID OUTSIDE OF THE STATE OF FLORIDA AND WHERE PROHIBITED OR RESTRICTED BY LAW.

The Choose My Name Sweepstakes ("Sweepstakes") is administered by The Florida Aquarium and Blue Cross and Blue Shield of Florida (BCBSF) d/b/a Florida Blue, 4800 Deerwood Campus Parkway, Jacksonville, FL 32246 ("Florida Blue" or Administrator").

- 1. SWEEPSTAKES PERIOD:** The Sweepstakes begins on March 19, 2019, at 12:01 PM Eastern Time ("ET") and ends on March 31, 2019, at 11:59:59 PM ET ("Sweepstakes Period"). The Sweepstakes is made up of thirteen (13) separate Sweepstakes, each with its own individual prize pool. Votigo, Inc. computer is the Sweepstakes' official clock.
- 2. ELIGIBILITY:** The Sweepstakes is offered only to legal residents of the State of Florida who are at least eighteen (18) years old at the time of entry. Officers, directors, agents, sales representatives, distributors and employees (and their respective household members and immediate family members, e.g., children, spouses, siblings, parents and the "steps" of each of the aforementioned) of Administrators, The Florida Blue Aquarium, BCBSF d/b/a Florida Blue, Guidewell Group, Inc. and any of its subsidiaries, including each of their respective parent companies, subsidiaries, affiliates and advertising, promotion and web design agencies ("Sweepstakes Entities") and all other individuals/entities associated with the Sweepstakes are not eligible to enter or win. Void outside of the State of Florida and where prohibited or restricted by law. All federal, state and local laws apply.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Administrators' decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein. Entrants and/or potential winners may be required to provide valid proof of identification and eligibility as required by Administrators.

- 3. HOW TO ENTER THE SWEEPSTAKES:** There are two (2) ways to enter the Sweepstakes:

A. Online: Entrants may participate in this Sweepstakes online by taking the following steps:

i. How to register online: During the Sweepstakes Period, an eligible entrant may visit the website Chose My Name (“Site”) and select one of the names displayed and enter a valid email address. The date of the entrant’s submission will identify the prize pool the entrant will be automatically entered into. There are thirteen (13) daily prize pools, each with its own prize, which are identified in greater detail in Section 5 of these Official Rules. Once an email address has been submitted, the entrant will not be able to change his/her submission and all of his/her entries will be in the prize pool for that period only. He/She is eligible to win only one daily drawing. If chosen as a daily winner, he/she will not be eligible for the prizes in the other prize pools.

NOTE: If an entrant accesses the Site from a mobile device, he/she understands data rates may apply. Entrants should check with their wireless service providers for details on these and other applicable charges. Entrants are solely responsible for any such wireless charges. Not all wireless carriers participate.

ii. How to obtain a weekly Sweepstakes entry: Upon submission of an email address, the entrant will automatically receive one (1) Sweepstakes entry into the prize pool for the period in which he/she entered. Every day thereafter during the Sweepstakes Period the entrant may return to the Site, submit a valid email address, and click “Submit” to receive one (1) Sweepstakes entry into the prize pool for the period he/she entered. There is a limit of one (1) Sweepstakes entry per entrant per day under this method of entry. A “day” is defined as starting at 12:00:00 AM ET and ending at 11:59:59 PM ET.

NOTE: An entrant’s submission of an email address or video through the “Choose My Name” application also serves as the entrant’s consent to receive information from The Florida Aquarium at that email address. The entrant may unsubscribe at any time.

All Sweepstakes entries made online must be made by March 31, 2019, at 11:59:59 PM ET.

B. Mail-In: Entrants may enter the Sweepstakes by mail by legibly handwriting a letter with his/ her complete name (no initials), age, valid e-mail address, and specify which his/her designation of the daily Prize Pool he/she would like to be entered into (ex: Day 1 Prize Pool) to: The Choose My Name Sweepstakes – Mail-In Entry, Florida Blue Social Media, 4800 Deerwood Campus Parkway, DCC 200-5, Florida 32246 (a “Mail-In Entry”) to obtain one (1) entry into the Sweepstakes. An entrant may send a total of thirteen (13) Mail-In Entries during the entire Sweepstakes Period – one (1) for each day. All Mail-In Entries made by this method must be received by day of the

Prize Pool closing as outlined in Section 4. The cost of mailed in entries will remain the responsibility of the participant, and is not reimbursed.

Mail-In Entries will not be returned and no further correspondence will be entered into. Mail-In Entries must be original and hand-written. No mechanical reproductions allowed.

Regardless of period of entry selected by an entrant, an entrant may only enter the Sweepstakes once per day during the Sweepstakes Period. If it is discovered or suspected that an entrant has registered for, entered, attempted to register for, or attempted to enter the Sweepstakes using multiple e-mail addresses or multiple identities, or in excess of the stated entry limits above, all of that entrant's entries will be declared null and void and any prize that entrant might have been entitled to receive or win will not be awarded. Use of any automated system or any like methods to participate in the Sweepstakes is prohibited and will result in disqualification of any entrant attempting such use.

4. PRIZE POOLS, PRIZES, ODDS OF WINNING, AND APPROXIMATE RETAIL VALUE ("ARV"):

A. - vii. Day 7: March 25, 2019, 12:00 a.m. (midnight) ET - 11:59:59 p.m. ET
- viii. Day 8: March 26, 2019, 12:00 a.m. (midnight) ET - 11:59:59 p.m. ET
- ix. Day 9: March 27, 2019, 12:00 a.m. (midnight) ET - 11:59:59 p.m. ET
- x. Day 10: March 28, 2019, 12:00 a.m. (midnight) ET - 11:59:59 p.m. ET
- xi. Day 11: March 29, 2019, 12:00 a.m. (midnight) ET - 11:59:59 p.m. ET
- xii. Day 12: March 30, 2019, 12:00 a.m. (midnight) ET - 11:59:59 p.m. ET
- xiii. Day 13: March 31, 2019, 12:00 a.m. (midnight) ET - 11:59:59 p.m. ET

B. Determination Of Daily Prize Winners: Daily winners will be determined by a random drawing from among all eligible entries received during the designated Prize Pool.

No changes will be made to prize dates once any element(s) of the prize arrangements have been booked, except at Administrators' sole discretion. Administrators will not replace any lost or stolen prizes, vouchers or certificates or similar items once they are in the possession of a winner or his/her authorized

representative(s) or delivered to the USPS or Federal Express or similar overnight courier delivery. Prize is not redeemable for cash or credits.

Administrators bear no responsibility if any event, element or detail of a prize is canceled, postponed or becomes unavailable for any reason. Should any event, element or detail of a prize become unavailable, the Administrators shall have no obligation to a winner aside from providing the material goods of the prize, minus any unavailable event, element or detail. C. Odds of Winning: The odds of winning a prize depend on the number of eligible Sweepstakes entries received during the Sweepstakes Period for that prize.

- 5. HOW TO CLAIM A PRIZE:** Approximately 72-96 hours after the close of the final Prize Pool, the potential winners will each be notified via e-mail from The Florida Aquarium or Florida Blue or its authorized designee at the e-mail addresses they individually submitted when entering the Sweepstakes (“Notification”). Winners will be required to complete must complete and return an Affidavit of Eligibility, a Liability Release and, where permissible, a Publicity Release, and tax acknowledgment form (“collectively, Affidavit”), which will be sent with the Notification. The completed Affidavit must be signed and notarized and returned to Florida Blue or its authorized designee for receipt within seven (7) calendar days from the date it was sent to the potential winner or the prize may, in Sponsors’ sole and absolute discretion, be forfeited. In the event that any e-mail is returned as undeliverable, or if no response to the Notification is received within the time period stated, or if the potential winner does not comply with these Official Rules, the prize may, in the Administrators’ sole and absolute discretion, be forfeited and another winner may be selected.

The Florida Aquarium or Florida Blue or its authorized designee will contact verified winners to arrange coordination of prize within approximately two (2) to three (3) weeks of confirmation of eligibility. Prizes will not be mailed to a PO Box. The right to receive a prize is non-assignable, non-transferable and no prize substitution, exchange or cash equivalent will be allowed, except by Administrators, who reserve the right to substitute a prize of equal or greater value in case of unavailability of a prize or force majeure, at Administrators’ sole and absolute discretion. Further, Administrators reserve the right to substitute a prize with a prize of equal or greater value, including, without limitation, the cash value of a prize, at their sole and absolute discretion. All other costs and expenses not expressly set forth herein shall be solely the winner’s responsibility. Sweepstakes Entities shall not be held responsible for any delays in awarding a prize for any reason. Each prize will only be awarded to a verified winner.

The Released Parties are not responsible for any incorrect or inaccurate information, whether caused by any Website users, tampering, hacking or by any of the equipment or programming associated with or utilized in the Sweepstakes and assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, technical error, theft or destruction or unauthorized access to the Facebook page or any Sweepstakes-related website(s). The Sweepstakes is subject to all federal, state and local laws and regulations.

By entering the Sweepstakes, each entrant agrees: (i) to be bound by these Official Rules and by all applicable laws and by the decisions of Administrators, which shall be binding and final; (ii) to waive any rights to claim ambiguity with respect to these Official Rules; (iii) to waive all of his or her rights to bring any claim, action or proceeding against any of the Released Parties in connection with the Sweepstakes; and (iv) to forever and irrevocably agree to release and hold harmless each of the Released Parties from any and all claims, lawsuits, judgments, causes of action, proceedings, demands, fines, penalties, liability, costs and expenses (including, without limitation, reasonable outside attorneys' fees) that may arise in connection with: (a) the Sweepstakes, including, but not limited to, any Sweepstakes-related activity or element thereof, and the entrant's submissions, participation or inability to participate in the Sweepstakes, (b) the violation of any third-party privacy, personal, publicity or proprietary rights, (c) typographical or printing errors in these Official Rules or any Sweepstakes materials, (d) acceptance, attendance at, receipt, travel related to, participation in, delivery of, possession, defects in, use, non-use, misuse, inability to use, loss, damage, destruction, negligence or willful misconduct in connection with the use of a Prize (or any component thereof), (e) any change in the prizing (or any components thereof)

7. **DISPUTES:** THE SWEEPSTAKES IS GOVERNED BY, AND WILL BE CONSTRUED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF FLORIDA, AND THE FORUM AND VENUE FOR ANY DISPUTE SHALL BE IN THE COUNTY OF DUVAL, FLORIDA. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY THE AMERICAN ARBITRATION ASSOCIATION IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("AAA RULES"). THE AAA RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN FLORIDA. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN DUVAL COUNTY,

FLORIDA. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES, INCLUDING ATTORNEY'S FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ANY DEMAND FOR ARBITRATION MUST BE FILED WITHIN ONE (1) YEAR OF THE TIME THE CAUSE OF ACTION ACCRUED, OR THE CAUSE OF ACTION SHALL BE FOREVER BARRED.

Further, entrants hereby waive all rights to: (i) claim punitive, exemplary, special, incidental, indirect and consequential damages and any other damages (whether due to negligence or otherwise); and (ii) have damages multiplied or otherwise increased. Entrants agree that the rights and obligations of any entrant and/or Sweepstakes Entities and/or any other party shall be resolved individually, without resort to any form of class action.
