

2021 Coast Packing Co. Fifth Annual #LardLovers Recipe Contest

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: This Contest is open only to those who sign up at <http://www.coastpacking.com/lardlovers/> and who are [21 years of age or older] as of the date of entry. The Contest is only open to legal residents of [the United States of America], and is void where prohibited by law. Employees, officers and directors of [Coast Packing Co.], its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the "Employees"), and immediate family members and/or those living in the same household (whether related or not) of Employees are not eligible to participate in the Contest. The Contest is subject to all applicable federal, state, and local laws and regulations. Void where prohibited.
2. Agreement to Rules: By participating, the Contestant ("You") agree to be fully unconditionally bound by these Rules, and You represent and warrant that You meet the eligibility requirements. Contest Period: Entries will be accepted online starting on [Friday, November 1, 2021 at 12:00:01am Pacific Standard Time] and ending [Friday, November 21, 2021 at 11:59:59 pm Pacific Standard Time]. All online entries must be received by [Friday, November 21, 2021 at 11:59:59 pm Pacific Standard Time]. Coast Packing Co. is the official time keeper for the Contest.
4. How to Enter: The Contest must be entered by submitting an entry using the online form provided at <http://www.coastpacking.com/lardlovers/>. The entry must fulfill all Contest requirements, as specified, to be eligible to win a prize. Entries that are incomplete or do not adhere to the rules or specifications may be disqualified at the sole discretion of [Coast Packing Co.]. You may enter only once. You must provide the information requested. You may not enter more times than indicated by using multiple email addresses, identities, or devices in an attempt to circumvent the rules. If You use fraudulent methods or otherwise attempt to circumvent the rules, your submission may be removed from eligibility at the sole discretion of [Coast Packing Co.]. In the event an insufficient number of entries are received, Coast Packing Co. reserves the right to cancel the Contest and shall be under no obligation to award the prizes.
5. All entrants in this Contest agree to the Recipe Submission Disclaimer. To enter the Contest, the entrant must submit a recipe (or recipes) using the Contest online submission form at <http://www.coastpacking.com/lardlovers/>. A limit of 2 recipes (1 recipe per category) per person will be strictly enforced. Recipes must contain lard. Entry must: (1) Be assigned to one of two categories, which are: savory or sweet; (2) include recipe name and the number of servings that the recipe yields, (3) use ingredients available in most grocery stores; (4) list ingredients with measurements; (5) include step-by-step preparation and cooking directions; (6) include entrants name, complete address with zip code, telephone number with area code and e-mail address; and, (7) a high-resolution original photograph of each recipe submitted.

Entries will be judged separately, in accordance with the judging criteria, as defined below. Judges will consist of Coast Packing Co. staff and non-staff food journalists. Proof of submission is not proof of receipt. Entries must be made by the authorized account holder of the email address submitted at the time of entry. "Authorized account holder" is defined as the natural person who is assigned to an email address by an internet access provider, online service provider, internet domain owner, or other person or organization that is responsible for assigning email addresses for the domain associated with the submitted email address.

SELECTION OF FINALISTS AND WINNERS

Each recipe submitted must be approved by a staff member of Coast Packing Co. Recipes may be approved or rejected based on suitability (for example, must comply with rules) for the Contest at the discretion of Coast

Packing Co. Only those recipes approved will be deemed eligible to win the Contest. Coast Packing Co. reserves the right to reject any entries that it deems, in its sole discretion, to be inappropriate, for any reason whatsoever. The judging period will begin on November 22, 2021 and conclude on December 5, 2021. Winners will be announced on National Lard Day, Wed, December 8, 2021. Winners must agree to have their name and photo included in Coast's news release announcing contest winners.

Members of the Coast Packing Co. staff will determine the finalists in each category. Recipe finalists will be determined based on the following criteria: creativity, visual appeal and ease of execution (how easy is this recipe to make by the average home cook). Recipes determined to be finalists will be prepared (cooked) by Coast Packing Co. staff. The top three winning recipes in each category will then be determined by a panel of three food journalists based on the following criteria: creativity, visual appeal and flavor. Contestants agree to be bound by these rules and the decision of the judges, whose decisions are final.

6.
