### GIVING TUESDAY SWEEPSTAKES OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER, WIN OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.

OPEN ONLY TO LEGAL RESIDENTS OF FLORIDA WHO ARE AT LEAST 18 YEARS OLD AT THE TIME OF ENTRY.

### VOID OUTSIDE OF THE STATE OF FLORIDA AND WHERE PROHIBITED OR RESTRICTED BY LAW.

- ELIGIBILITY: The Sweepstakes is offered only to legal residents of the State of Florida who are at least eighteen (18) years old at the time of entry. Upon completion and submission of the photo, video or essay submission form, the entrant will receive a confirmation message that their information has been received. The date of the entrant's photo, video or essay submission will identify the prize pool the entrant will be automatically entered into. The prize pool, is identified in greater detail in Section 4 of these Official Rules.

**NOTE:** If an entrant accesses the Page from a mobile device, he/she understands data rates may apply. Entrants should check with their wireless service providers for details on these and other applicable charges. Entrants are solely responsible for any such wireless charges. Not all wireless carriers participate.

ii. How to obtain a Sweepstakes entry: Upon submission of a photo, video or essay, the entrant will automatically receive one (1) Sweepstakes entry into the prize pool for the period in which the sweepstakes takes place. The entrant may return to the Page, submit a new photo, video or essay, and click "Submit" to receive one (1) additional Sweepstakes entry into the prize pool during the sweepstakes. All Sweepstakes entries made online must be made by December 6, 2019, at 11:59:59 PM ET.

**B. Mail-In:** Entrants may enter the Sweepstakes by mail by legibly handwriting a letter with his/her complete name (no initials), street address (P.O. Use of any automated system or any like methods to participate in the Sweepstakes is prohibited and will result in disqualification of any entrant attempting such use.

- **B.** Determination Prize Winners: Qualified entries will be placed in a random drawing to select the winner. All costs and expenses not specifically included herein are solely each winner's responsibility, as are all federal, state and local taxes.

No changes will be made to prize dates once any element(s) of the prize arrangements have been booked, except at Administrators' sole discretion. Administrators will not replace any lost or stolen prizes, vouchers or certificates or similar items once they are in the possession of a winner or his/her Guest(s). Prize is not redeemable for cash or credits.

ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN DUVAL COUNTY. FLORIDA. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, CONSEQUENTIAL OR INCIDENTAL DAMAGES, INCLUDING ATTORNEY'S FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ANY DEMAND FOR ARBITRATION MUST BE FILED WITHIN ONE (1) YEAR OF THE TIME THE CAUSE OF ACTION ACCRUED, OR THE CAUSE OF **ACTION SHALL BE FOREVER BARRED.**
