# The Great Hawaiian Host-ess Search Official Rules

# NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

# 1. Eligibility

The Great Hawaiian Host-ess Search (the "Contest") is open only to legal residents of Hawaii who are eighteen (18) years or older at the time of entry. Void where prohibited by law. Employees of Hawaiian Host, Inc. and Hendrix Miyasaki Shin Advertising, Inc. or any of their respective affiliates, subsidiaries, advertising agencies, or any other company or individual involved with the design, production execution or distribution of the Contest and their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members (people who share the same residence at least three (3) months out of the year) of each such employee are not eligible. The Contest is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Contest. # 2. Sponsor and Administrator

#### 3. Timing - Submission Period

The Contest begins on August 13, 2012 at 12:00 a.m. Hawaii-Aleutian Standard Time ("HST") and ends on October 31, 2012 at 11:00 p.m. HST (the "Submission Period") Sponsor's computer is the official time keeping device for this Contest.

#### 4. How to Enter

During the Submission Period you can enter through The Great Hawaiian Host-ess Search Contest application tab on the Hawaiian Host, Inc. Page (facebook.com/pages/Hawaiian-Host). In order to access The Great Hawaiian Host-ess Search Contest tab, you must first "like" (or have previously "liked") the Hawaiian Host Page. To register for the Contest you must provide your name, address, age and email address. Then you'll be able to upload photo(s) of yourself that show why you should be the next Hawaiian Hostess (the "Photo"). You may submit more than one Photo for a single entry, up to a maximum of 5 Photos. If you want to submit more than one Photo you must upload each individually. It is required that one Photo be a headshot and suggested that another Photo be a full body shot. Limit of one (1) entry per person during the Submission Period. Multiple participants are not permitted to share the same email address or Facebook account. Use of any automated system to enter is prohibited and will result in disqualification. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible or misdirected uploads, which will be disqualified.

#### Photo Requirements

**Photo must only contain one individual, the entrant**. Photo must be the original work of the entrant; must not have won previous awards; must not have been used publicly previously by any third party; must not infringe any third-party's rights; must be suitable for publication (i.e., may not be obscene or indecent); must not contain obscene or pornographic material; must not invade privacy, publicity or other rights of any person, firm or entity; must not in any other way violate applicable laws and regulations; must not contain any reference to any third party trademarks, names or third party logos; and must not contain any copyrighted works owned by third parties. All Photos will be reviewed for content eligibility and compliance with these Official Rules before being judged. Photos containing prohibited material or inappropriate content, as determined by the Sponsor, in its sole discretion, may be disqualified. Sponsor makes the final determination as to what Photos are eligible to take part in this Contest. Submission of a Photo grants Sponsor and its agents the unconditional, irrevocable, worldwide

right to publish, use, adapt, edit and/or modify such Photos in any way, in any and all media, without limitation, and without consideration to the entrant, whether or not such entry is selected as a winning entry. BY SUBMITTING THE ORIGINAL PHOTO, THE ENTRANT REPRESENTS AND WARRANTS THAT HE/SHE HAS ALL RIGHT, TITLE AND INTEREST NECESSARY TO GRANT THE SPONSOR THE WORLDWIDE, IRREVOCABLE AND UNRESTRICTED RIGHT AND LICENSE TO ADAPT, PUBLISH, USE, EDIT, AND/OR MODIFY SUCH ENTRY IN ANY WAY AND POST THE ORIGINAL PHOTO ON THE INTERNET OR USE THE ORIGINAL ENTRY IN ANY OTHER WAY AND AGREES TO INDEMNIFY AND HOLD SPONSOR AND ADMINISTRATOR HARMLESS FROM ANY CLAIMS TO THE CONTRARY.

#### 5. Finalist Selection

All Photos will be judged by a panel of qualified judges ("Judges") to select nine (9) finalists. The Photos will be judged solely on the following criteria: Best exemplifies the spirit of Hawaiian Host. The nine (9) individuals whose entry earns the highest overall score will have the opportunity to compete for the grand prize. All Photos will be displayed and available for public voting between August 13, 2012 and October 31, 2012 on The Great Hawaiian Host-ess Search Contest application tab. The Entrant that receives the most votes (based on all of her Photos) will also be a finalist. Entrants agree that the Sponsor, Administrator and judges have the sole right to decide all matters and disputes arising from this Contest and that all decisions of Sponsor, Administrator and judges are final and binding. Judges will be fair and impartial. Decisions of the judging panel will be final. Judging to determine the finalists will be complete on or about November 7, 2012.

### 6. Verification of Potential Finalists and Selection of Grand Prize Winner

The potential finalists must continue to comply with all terms and conditions of these Official Rules, and winning is contingent upon fulfilling all requirements. The potential finalists will be notified by email, telephone, on or about November 14, 2012. The potential finalists will be required to respond to the Sponsor or Administrator, within five (5) days of the date notice is sent acknowledging that they want to be a finalist. If the potential finalist cannot be contacted, fails to respond within the required time period or if the notification is returned as undeliverable, potential finalist forfeits their opportunity to be a finalist. All finalists are subject to a background check (including, without limitation, civil and criminal court records and police reports). Sponsor reserves the right in its sole discretion to disqualify any finalist if the results of such background check reveals that the entrant would reflect negatively on Sponsor or any of its related or affiliated companies, employees, or affiliates. The interview will be scheduled at a date and time that is mutually convenient but will be between November 26, 2012 and December 14, 2012. The one finalist that best exemplifies the spirit of Hawaiian Host will be the potential grand prize winner. The potential grand prize winner will be contacted on or about December 21, 2012.

# 7. POTENTIAL CONTEST WINNER IS SUBJECT TO VERIFICATION BY SPONSOR AND ADMINISTRATOR WHOSE DECISIONS ARE FINAL AND BINDING IN ALL MATTERS RELATED TO THE CONTEST.

#### 8. Verification of Grand Prize Winner

Potential grand prize winner must continue to comply with all terms and conditions of these Official Rules and winning is contingent upon fulfilling all requirements of the Official Rules. The potential grand prize may be required to sign and return to Sponsor, within five (5) days of the date notice is sent, an affidavit of eligibility, and liability/publicity release (except where prohibited) as well as other document required by the Sponsor in order to claim his/her prize if applicable. If a potential winner of any prize cannot be contacted, fails to sign and return the document within the required time period or if the prize or prize notification is returned as undeliverable, potential winner forfeits prize. Sponsor and/or Administrator reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor and/or Administrator reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor and/or Administrator's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. In the event of a dispute as to any registration, the authorized account holder of the email address used to register will be deemed to be the registrant or entrant. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider or other organization responsible for assigning email addresses for the domain associated with the submitted address. Potential winners may be required to show proof of being the authorized account holder.

# 13. Limitations of Liability

The Released Parties are not responsible for: (a) any incorrect or inaccurate information, whether caused by entrants, printing errors or by any of the equipment or programming associated with or utilized in the Contest; (b) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (c) unauthorized human intervention in any part of the entry process or the Contest; (d) technical or human error which may occur in the administration of the Contest or the processing of entries; or (e) any injury or damage to persons or property which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest or receipt or use or misuse of any prize. If for any reason an entrant's entry is confirmed to have been erroneously deleted, lost, or otherwise destroyed or corrupted, entrant's sole remedy is another entry in the Contest, provided that if it is not possible to award another entry due to discontinuance of the Contest, or any part of it, for any reason, Sponsor and/or Administrator, at its discretion, may select the winners from among all eligible entries received up to the date of discontinuance for any or all of the prizes offered herein. Entrant agrees that: (a) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, other than those concerning the administration of the Contest or the determination of winners, shall be resolved individually, without resort to any form of class action; (b) any and all disputes, claims and causes of action arising out of or connected with this Contest, or any prizes awarded, shall be resolved exclusively by the United States District Court or the appropriate Hawaii State Court located in Honolulu County, Hawaii; (c) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Contest, but in no event attorneys' fees; and (d) under no circumstances will entrant be permitted to obtain awards for, and entrant hereby waives all rights to claim punitive, incidental and consequential damages and any other damages, and any and all rights to have damages multiplied or otherwise increased. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY FOR INCIDENTAL OR CONSEQUENTIAL DAMAGES. SO THE ABOVE MAY NOT APPLY TO YOU. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor and/or Administrator in connection with the Contest, shall be governed by, and construed in accordance with, the laws of the State of Hawaii, without giving effect to any choice of law or conflict of law rules (whether of the State of Hawaii or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Hawaii.
