Annual Calendar Photo Competition 2019

Competition Rules and Regulations:

- 1. All participants must be using Robertson Geo (RG) geophysical well logging equipment or services in picture submission.
- 2. All work submitted must be entirely the work product of the applicant. The only exception is for photos taken of you, however, you must also provide written consent from the photographer along with your submission. You are further required to comply with all UK and international copyright laws, trademark laws, and any and all laws regarding intellectual property both in the United Kingdom and in your jurisdiction. You assert that no such laws have been violated when making your submission. You will hold RG harmless for any violations in connection with the image(s) submitted.
- 3. No purchase necessary to enter the competition.
- 4. **Photo Submission:** The submission cannot have been submitted previously in a promotion of any kind or exhibited or displayed publicly through any means. We reserve the right to reject any photos which we, in our sole and absolute discretion, deem offensive, violation of law or unsuitable in any other manner. RG is not required to provide any explanation for the rejection.

Examples of the following types of photos we will reject include the following:

- Pornographic or nude images
- Images promoting illegal drug use
- Images depicting crimes of any nature

Photo Guidelines:

- The Submission must be in .jpg or .png format; picture submission must be at least 5 MB (please submit the highest quality image with regard to file size, bit depth and resolution)
- Must provide a high-resolution copy of submission upon winning
- Submissions that have been digitally altered beyond standard optimization (removal of dust, cropping, reasonable adjustments to exposure, color and contrast, etc.) will be disqualified
- Subjects in submission must be at least 18 years of age. Submissions promoting children will be rejected.
- 5. You retain your rights to your photograph; however, by entering the contest, you grant the Robertson Geo (and those authorised by RG) a royalty-free, world-wide, perpetual, non-exclusive license to publicly display, distribute, reproduce, and create derivative works of the entries, in whole or in part, in any media now existing or later developed, for any RG purpose, including, but not limited to, advertising and promotion of a magazine and its website, exhibition, and commercial products, including but not limited to RG publications. Any photograph reproduced will include a photographer credit as feasible. RG will not be required to pay any additional consideration or seek any additional approval in connection with such uses.
- 6. During the Competition Period the general public will be invited to vote for the submission they believe has the most public appeal. Pending compliance with these Official Rules, the twelve (12) entrants with the highest-scoring submissions will be deemed a potential Prize winner and considered our semi-finalists.

A maximum of (3) photographs can be submitted on behalf of any one company/individual, with exception to those companies that have multiple locations as verified by RG. In which case, each location may submit a maximum of (3) photographs. A company with multiple locations can be represented by no more than 3 images in the semi-finalist round.
