## 2017-2018 Global Photo Contest - OFFICIAL RULES

### How to Enter

**NO ENTRY FEE. NO PURCHASE NECESSARY TO ENTER OR WIN. VOID WHERE PROHIBITED BY LAW.**

#### Enter by Direct Submission:

- Select "Enter Now"
  - Upload and submit your photo
  - Check your email for the link to your entry

### General Contest Requirements

- While submissions may depict a range of environments and backgrounds, all photos must include at least one Trimble Real-Time Network product and a brief description of where it is and what it is being used for.
- All submissions must be the original photography work of the entrant.
- There is no limit on the number of photo entries an entrant may submit (however 'best shots' preferred).
- The first and last name provided on the entry form will be the identity of the entrant and, if selected for the prize, the identity of the winner. The use of a bogus name, street address or email address will disqualify an entrant.
- A photo can only be entered once. Any photos submitted more than once will be removed from the contest.
- Submissions cannot contain, as determined by Sponsor, content that is sexually explicit, violent, and derogatory of any ethnic, racial, gender, religious, professional or age group, which violates any law, or which communicates a message inconsistent with the positive good will to which we wish to associate.
- Entries will be accepted online starting at 12:00pm Mountain Standard Time on 7th November 2017. All entries must be received by **11:59pm Mountain Standard Time on 7th November 2018**. The winner will be announced on 30th November 2018.

All entrants agree to abide by these Official Rules. All entries, photos and videos become the property of Trimble Advanced Positioning.

## **Eligibility**

All entrants must be at least 18 years of age and a legal resident of the country specified in their entry form. Employees and immediate families or household members of Trimble, its affiliates and subsidiaries are not eligible to enter the Contest. The Contest is void in Cuba, Italy, Iran, Iraq, Myanmar, North Korea, Sudan, Syria, the Province of Quebec, and any place where the offering of the Contest or the awarding of a prize is prohibited and/or strictly regulated. ## **Photo Specifications**

- Photos must be in .jpg, .jpeg, or .png format.
- There can be no added text or elements on your photo.
- Preference will be given to photos without filters.
- The minimum resolution for any photo that would be considered for inclusion in Trimble RTN publications, signage, or any other promotional material is 13" wide x 11.5" high at 300 dpi or 3900 pixels wide x 3200 pixels high.

## **Prize**

The prize will be awarded to the contest participant for the submitted photo chosen by Morag Greenberg. There will be one (1) winner. The prize will be an iPad tablet computer designed, developed and marketed by Apple Inc.

## **Odds of Winning**

The odds of winning are dependent upon the number of entries received.

## **General Conditions and Releases**

The Contest is void where prohibited or restricted by law in the United States and in all other countries and is subject to all United States and other countries federal, state and local laws and regulations (including United States Export Regulations).
