

“You Take Me Home” Ultimate Dream Vacation Contest Rules and Regulations

How to Enter:

- Applicants will be asked to enter a video no longer than 1min 30 seconds and answering the following question:

“What is your story and why do you deserve to win a Dream Vacation for 2 to Australia with the option to join Joanne Janzen on a portion of her “You Take Me Home” Queensland Tour!”
- Contest Entries are uploaded at Joanne Janzen’s Facebook Page (<https://www.facebook.com/joanne.janzen.music>) or if you are not a Facebook member you can enter at Joanne’s website: www.joannejanzen.com where each contestant will enter entry information and also be prompted to upload their video. Please note there is a fun question regarding Joanne’s song “You Take Me Home” and it’s lyrics that will need to be answered in order for the entry to be valid.
- TOP 10 video entries will be selected from a panel of judges and reference checked before being announced
- The top 10 videos will be posted on Joanne Janzen’s Facebook Page and website for Canada to vote (one vote per Canadian) for their favorite story/video

ELIGIBILITY:

- To enter and be eligible to win, a person must be a legal resident of Canada (excluding Quebec) who has reached the age of majority in the jurisdiction in which he/she resides at the time of entry.
- Employees of the Sponsor, its advertising agencies and/or promotional partners, and members of their immediate family (defined as parents, children, siblings, and spouse) together with those with whom such employees are domiciled, are not eligible to enter.

- All flights and tour will be booked via Maritime Travel, except travel insurance.
