

OFFICIAL RULES

Bosch Power Tools "FB Refer a Friend Sweepstakes"

VOID WHERE PROHIBITED BY LAW

1. Eligibility: The Bosch Power Tools Refer a Friend Facebook Sweepstakes ("Sweepstakes") is open to legal residents of the 50 United States, the District of Columbia and the various provinces of Canada (other than the Province of Quebec) who are 18 years of age (or the age of majority in their respective jurisdiction, whichever is greater) or older as of date of the Sweepstakes entry. The Sweepstakes is governed by and subject to all U.S. federal, state and local laws. The Sweepstakes is void outside the U.S. and Canada, in the Province of Quebec, Puerto Rico, other U.S. territories and possessions, U.S. military installations, and where prohibited by law. By participating in the Sweepstakes, participants agree to be bound by these Official Rules and the decisions of the Sponsor, which shall be final and binding in all respects. The Sweepstakes is not sponsored, administered or endorsed by or associated with Facebook, Inc. ("Facebook"), and participants are providing information to Sponsor and the Sweepstakes facilitator, Votigo Inc., 251 Lafayette Circle, Suite #330, Lafayette, CA 94549, <http://www.votigo.com> (the "Facilitator"), not to Facebook.

2. Entry and Eligibility: The Sweepstakes period begins Thursday, October 3, 2013 at 7:00 a.m. CDT and ends Wednesday, October 10, 2013 at 12:00 a.m. CDT ("Promotion Period"). To enter the Sweepstakes: **(A)** visit and log onto Sponsor's Facebook page at <http://www.facebook.com/boschtoolsNA> during the Promotion Period and **(B)** follow the instructions provided in the Sweepstakes page. Limit one (1) entry, (entrants receive additional entries for social sharing and one additional entry for each person who enters through their custom share link) per **(A)** person; **(B)** household; **(C)** dwelling; **(D)** computer (home or business); **(E)** email address or account (home or business); and **(F)** Facebook account. Employees, officers and directors of **(i)** Sponsor, Sponsor's parent company, subsidiaries, affiliates, dealers and distributors; **(ii)** Facilitator; **(iii)** Facebook and the immediate families of each of the foregoing are not eligible to enter the Sweepstakes. Any entry in violation of these rules, including any attempt by a participant to use multiple Facebook or e-mail accounts to multiply the number of entries is prohibited and will result in disqualification.

3. Winner; Odds of Winning. Winning entries will be drawn at random on Friday, October 18, 2013 at approximately 11:00 a.m. CDT, from among all eligible entries received during the Promotion Period. Odds of winning will depend on the number of valid entries received within the Promotion Period. The decision of the Sponsor will be final and binding with regard to the selection of the winners. Sponsor will notify the winner by telephone or e-mail on or about October 21, 2013 and, to claim the Prize, the winner must meet all eligibility requirements. 4. Prize; Approximate Retail Value of Prize: Six (6) prizes will be awarded consisting of a Bosch Heated Jacket (PSJ120), with a retail value of approximately \$229.00 (USD). No prize substitutions or cash equivalents of prize are permitted except at Sponsor's sole discretion, and then only for a prize of equal or greater value. Sponsor reserves, at its sole discretion, the right to substitute a prize of equal or greater retail value. Sponsor will pay for standard ground shipping to a valid address within the United States or Canada, by carrier determined by Sponsor. Allow 4-8 weeks for processing and handling.

5. Conditions of Participation & Certain Restrictions: The Prize is non-transferable, non-assignable, and non-redeemable in cash, except in Sponsor's sole discretion. The winner is responsible for all federal, state, provincial and local taxes associated with receipt of the Prize. Winner must provide a valid U.S. or Canadian mailing address for shipment of the Prize. Sponsor is not responsible for

technical, hardware or software failures of any kind, lost or unavailable network connections, or incomplete or garbled computer transmissions that might limit any participant's ability to participate in the Sweepstakes. Sponsor reserves the right to cancel or modify the Sweepstakes or disqualify a participant if fraud or technical failures destroy or undermine the integrity of the Sweepstakes as determined by the Sponsor. All entries submitted will be the property of the Sponsor and will not be acknowledged or returned. Information submitted by participants in connection with the Sweepstakes will be used only by Facilitator (not by Facebook) for the purposes of administering the Sweepstakes, in accordance with Facilitator's privacy policy which may be found at www.votigo.com, and otherwise by Sponsor, in accordance with Sponsor's privacy policy found at <http://www.boschtools.com/termsfuse/privacypolicy/Pages/PrivacyPolicy.aspx> and otherwise as expressly stated in these Official Rules.

6. Release of Liability: By participating in the Sweepstakes, participant releases Sponsor, Facilitator, Facebook, and their respective officers, directors, agents, employees and all entities associated with the Sweepstakes ("Released Parties") from any and all liability arising from participation in the Sweepstakes, or acceptance or use of any Prize. Participant also agrees that the Released Parties are not responsible or liable for any injury, loss or damage to or incurred by a person, including death or property damage due in any manner to the acceptance, use, or misuse of a Prize or participation in the Sweepstakes.

7. Governing Law & Dispute Resolution: All controversies regarding the Sweepstakes shall be governed by, and construed in accordance with, the laws of the State of Illinois, without giving effect to any choice of law rules or provisions. For any controversy or claim that arises regarding the Sweepstakes and that is not resolved through negotiation, Sponsor and participant agree to resolve such controversy or claim through binding arbitration in Chicago, IL, in accordance with the then current Arbitration Rules of the American Arbitration Association, and judgment on any award made by the arbitrator may be entered in any court having jurisdiction thereof. Any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering the Sweepstakes, but in no event attorney's fees. Under no circumstances will a participant be permitted to obtain any award for, and participant hereby waives all rights to claim, punitive, incidental, or consequential damages.

8. Additional Rules: Sponsor is not responsible for any typographical or other error in any communication relating to the Sweepstakes. If Sponsor is prevented from continuing with this Sweepstakes or the integrity and/or feasibility of the Sweepstakes is undermined by any event including but not limited to fire, flood, epidemic, earthquake, explosion, labor dispute, act of God or public enemy, equipment failure, riot or civil disturbance, war, terrorist threat or activity, or any federal, state or local government law, order, regulation or order of any court, or other cause not reasonably within the Sponsor's control (each a "Force Majeure" event), Sponsor has the right, in its sole discretion, to abbreviate, modify, suspend, cancel or terminate the Sweepstakes without notice or further obligation.
