CCA Texas Facebook Fan ICEHOLE Giveaway Rules

Please read these Official Rules before entering this promotion (the "Promotion"). By participating in the Promotion, you agree to be bound by these Official Rules and represent that you satisfy all of the eligibility requirements below.

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS PROMOTION.

1. **Eligibility.** The promotion is open only to legal residents of the state of Texas in the United States, age 18 or older (or the age of majority in entrant's state of residence), and who, upon entering the Promotion, at the time of the drawing, and if asked to provide an affidavit of eligibility following the drawing, have a user account on Facebook and "like" CCA Texas on Facebook. If an entrant is under the age of 18, he/she may enter contest, but upon winning must provide the name and email address of their legal guardian in order to receive prize. (b) **Bonus Entries on Facebook:** In submitting your Entry Form through Facebook, you will be provided with the option to click a button to "refer" to your friends. For each eligible individual who is invited by you and who fills out and submits an Entry Form in response to your invitation, you will receive an additional entry into the Promotion.
