

OFFICIAL RULES  
ETHAN ALLEN DREAMSTAKES 2016

NO PURCHASE NECESSARY TO ENTER OR WIN.

ELIGIBILITY: OPEN ONLY TO LEGAL RESIDENTS OF THE UNITED STATES (EXCLUDING ALASKA, HAWAII, PUERTO RICO AND OTHER TERRITORIES AND POSSESSIONS) AND OF CANADA (EXCLUDING QUEBEC, THE YUKON AND NORTHWEST TERRITORIES, AND MANITOBA ("TERRITORY")).
