

RENT.COM "AMINAL HOUSE" SWEEPSTAKES
OFFICIAL RULES

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

DATES OF SWEEPSTAKES: The "Animal House" Sweepstakes (the "Sweepstakes") begins at 10:00AM Pacific ("PT") on June 3, 2013 and ends at 2:59:59 PM PT on June 21, 2013 (the "Sweepstakes Period"), subject to entry periods (each, an "Entry Period") as outlined in the How To Enter Section of these Official Rules.
