

OFFICIAL RULES

SWEETWATER® BIG GREEN EGG SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. VOID WHERE PROHIBITED. MUST BE 21 YEARS OF AGE OR OLDER TO ENTER.

ELIGIBILITY: SweetWater® **BIG GREEN EGG SWEEPSTAKES** (the “Sweepstakes”) is open to legal residents of the United States of AL, FL, GA, IN, KY, NC, OH, SC, TN, & VA who are at least twenty-one (21) years of age at the time of entry. Limited one (1) entry per person, regardless of method of entry. Duplicate entries for a single individual will be disqualified. All entries become the property of the Sponsor.

PRIZE AND ODDS OF WINNING: Two (2) Total Prizes will be selected in a random drawing on about 5/1/2018 from all eligible entries received during the Sweepstakes Period. Two (2) Grand Prizes – Each winner will receive Large Big Green Egg prize package valued at \$1,200 and includes everything you need to get started with the Ultimate Cooking Experience: Large Big Green Egg with Nest, Mates, charcoal, starters, ash tool and grill gripper with an Approximate Retail Value (“ARV” - \$1,200.00.
