

OFFICIAL RULES

SWEETWATER® 420 FEST SWEEPSTAKES

NO PURCHASE NECESSARY TO ENTER OR WIN THIS SWEEPSTAKES. VOID WHERE PROHIBITED. MUST BE 21 YEARS OF AGE OR OLDER TO ENTER.

ELIGIBILITY: SweetWater® 420 FEST SWEEPSTAKES (the “Sweepstakes”) is open to legal residents of the United States of GA, NC, & TN who are at least twenty-one (21) years of age at the time of entry. Employees (and their immediate families) of The SweetWater Brewing Company (the “Sponsor”), Reconomy Inc., (the “Administrator”) and any of their parents, subsidiaries, affiliates, suppliers, independent contractors, agencies, alcoholic beverage wholesalers and retailers, and any persons living in the same household as such employees are not eligible to participate in the Sweepstakes (cumulatively, the “Sweepstakes Entities”). Sweepstakes is subject to all applicable federal, state, local laws and regulations and is void where prohibited by law. The Sweepstakes begins on 3/1/2018 at or about 12:01 a.m. Eastern Standard Time (“EST”) and ends 3/31/2018 at or about 11:59 p.m. EST (the “Sweepstakes Period”). Prize winners will be selected in a random drawing on or around 4/1/2018 for all eligible entries received during the Sweepstakes Period.

HOW TO ENTER: There are two (2) ways to enter:

2) **Internet:** Visit <http://www.420FestMac.com> (“Website”) and follow the online instructions to play for a chance to win a prize.

Limited one (1) entry per person, regardless of method of entry. Duplicate entries for a single individual will be disqualified. All entries become the property of the Sponsor.

PRIZE AND ODDS OF WINNING: Two (2) Total Prizes will be selected in a random drawing on about 4/1/2018 from all eligible entries received during the Sweepstakes Period. Two (2) Grand Prizes – A pair of VIP Passes to 420 Fest 2018 at Centennial Park in Atlanta, GA 4/20-4/22, double occupancy hotel accommodations for 3 nights, \$250 travel voucher/Expenses card, and 2 tickets to Brewery Party with an Approximate Retail Value (“ARV”) - \$2,000.00. All costs and travel expenses not expressly included above are the sole responsibility of winner. Winner and guests must be 21 years of age or older. The difference between any stated value and actual value will not be awarded to winner. The random drawing, selection of a winner, and awarding of the prize will be conducted under the supervision of Administrator, an independent organization whose decisions are final and binding in all matters pertaining to this Sweepstakes. No prize substitution will be allowed, except that Sponsor reserves the right to substitute a prize of comparable value if the prize listed is unavailable for any reason. WINNER NOTIFICATION: Potential prize winner will be notified by email, text message, U.S. mail, telephone, or private delivery service (at Sponsor’s sole discretion) and will be required to sign and return an Affidavit of Eligibility and Release of Publicity and Liability (where permitted by law) within three (3) days of notification. FORCE MAJEURE: Sponsor reserves the right to modify, extend, suspend, or terminate the Sweepstakes, in whole or in part, if it determines, in its sole discretion, that the Sweepstakes or any particular Sweepstakes drawing is technically impaired or corrupted or that fraud or technical problems, failures or malfunctions or other causes beyond Sponsor's control have destroyed or severely undermined or to any degree impaired the integrity, administration, security, proper play and/or feasibility of the Sweepstakes or particular sweepstakes drawing as contemplated herein.
